The organization is a packing house, cold storage and distribution facility that handles fresh produce (fresh/frozen seafood, meat, edible flowers, and other foodstuffs are also stored at the facility, but are outside the scope of the audit). The organization repacks fresh produce into smaller packages primarily for the food service industry and also warehouses fresh produce and other food items (fresh and frozen). Allergens (dairy, seafood, tree nuts and wheat) are handled at the facility, they are maintained in separate designated areas. There were approximately 35 workers during the inspection.
